ABOUT THE INSTITUTION

The Shillong Law College was established in 1964 as an evening college. Registered under the Societies Registration Act, No. XXI of 1860, the college is also listed under Section 2(f) and 12(B) of the UGC Act, 1956, and recognized by the Bar Council of India. Initially affiliated with Guahati University, the college came under the North Eastern Hill University (NEHU) in 1973 when NEHU was established. It was the outcome of the efforts made by the then eminent persons of the city like Late Lokeshwar Sharma, a scholar administrator and a remarkable educationist; Late Bhubesh Chandra Barua, the then Advocate General of Assam; Late Suresh Chandra Rajkhowa, the then Director of Public Instruction, Assam; Late Maham Singh, Advocate and former Minister, Assam; Late Aron Alley, Advocate and former Assam Minister, Late Dharendra Nath Dutta, Advocate; Late J.N Deb Choudhury, Advocate ; Late Shri Hasibuddin Ahmed, Advocate; Late Nripendra Mohan Palit, Advocate and Late Prabin Kumar Choudhury, the Editor of the then The Frontier Times. The college was granted permanent affiliation in 2007.

Currently, the Shillong Law College offers a 3-year LL.B. Degree Course and a 5-year B.A.LL.B Integrated Degree Course. Thousands of students have graduated from the college, many of whom hold prominent positions across the country, including Hon'ble Judges of High Courts, Advocate General, and Additional Advocate General of the State. Notably, former teacher Shri S. N. Phukan rose to the position of Chief Justice of the High Court of Himachal Pradesh and later became a Judge of the Supreme Court of India. Distinguished alumni include Justice Home Choudhury of the Guwahati High Court, Justice A.P. Subbah of the Guwahati and Sikkim High Courts, and Justice B. Lamare of the Guwahati High Court.

The college's illustrious alumni also include Hon'ble Justice W.Diengdoh, Judge of the High Court of Meghalaya, Justice B.Bhattacharjee, Judge of The High Court of Meghalaya, Hon'ble Justice (Retd) S.R. Sen of the High Court of Meghalaya and Justice Nelson Sailo of the Guwahati High Court. Several graduates have served as Registrar General of the High Court of Meghalaya, as well as District & Session Judges, Additional District and Session Judges, Assistant District Session Judges, and Judicial Magistrates.

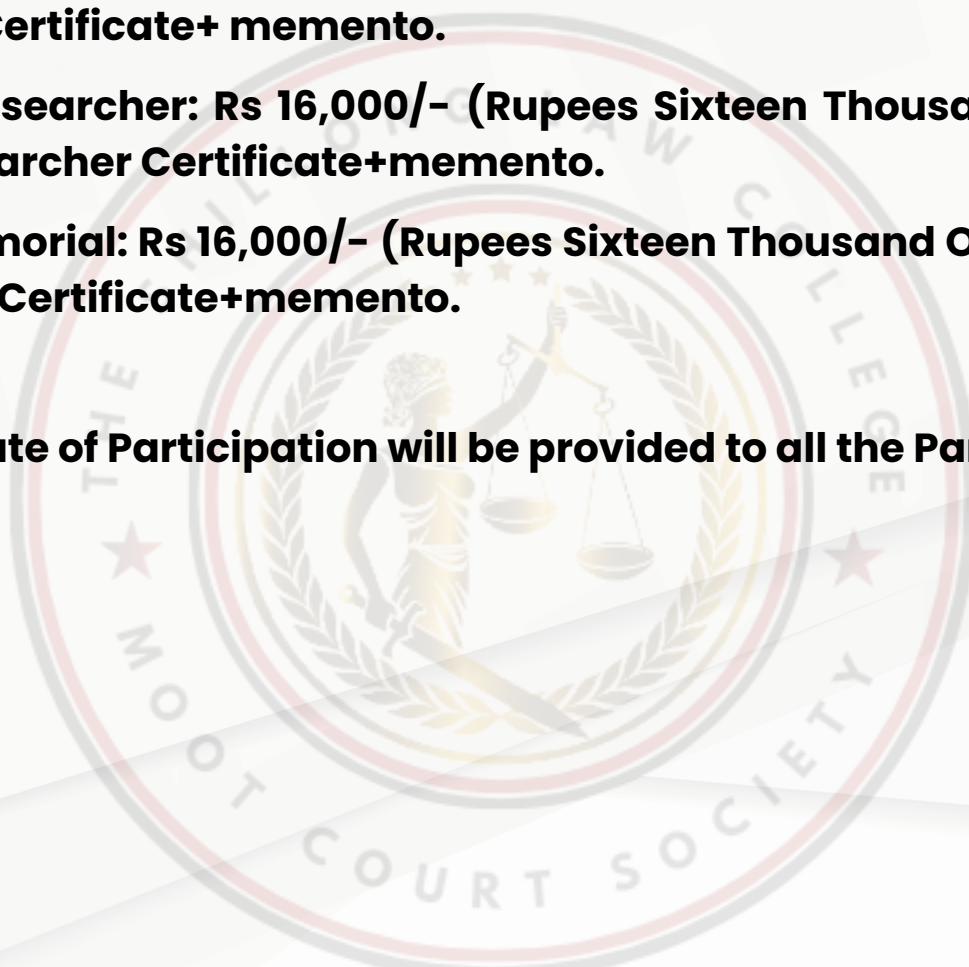

1) The last date of provisional registration is 10th July 2024 by 11:59:59 PM. The teams must register online by 10th July 2024.

2) The Registration fee is Rs. 3299/- without accommodation and with accommodation Rs. 4799/-. The provisional registration shall be done by filling up the registration form (Google Form) available at - <https://forms.gle/y59RnywnYbrWatSdA>

or scan here to fill out the form



3) Only after the provisional registration, the organising committee shall forward the final registration Link and bank details to the teams via their Email ID of the college and the Team leader. Thus, after the final Registration, the team codes shall be allotted. A maximum of 30 teams shall be registered on a first-come-first-serve basis.

4) The registration shall be considered complete only when the 'Registration Fee' has been paid successfully and the registration form is duly filled with all the credentials.

5) The participants will receive an official approval mail from the organizing committee after their registration.

6) The organizing committee shall communicate the unique team codes to each team through mail which shall be quoted by the teams after the final registration for further communications with the organising committee.

7) Registration fee once paid is non-refundable.
