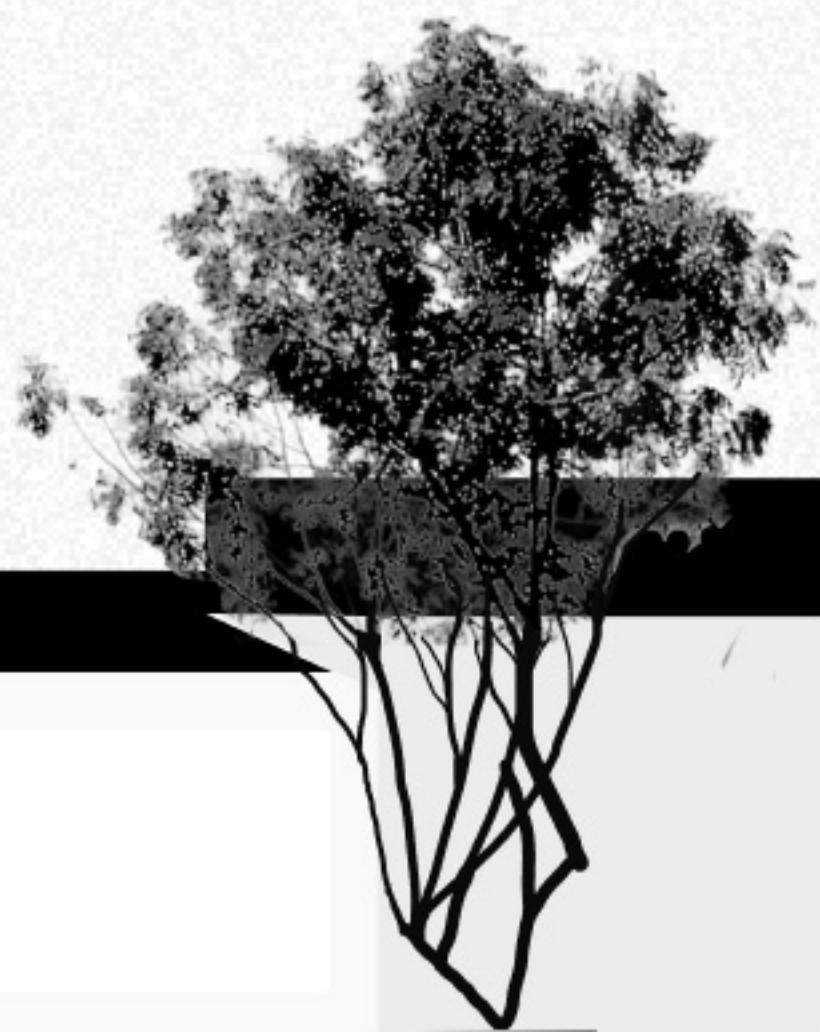

# ABOUT NALSAR

# THE BODH RAJ SAWHNY MEMORIAL TRUST



The Bodh Raj Sawhny Memorial Trust was founded in 1999 by Late Mr. Degamber Sen Sawhny, in memory of his father Justice Bodh Raj Sawhny. Bodh Raj Sawhny, an eminent jurist, was born in Bhera, Shahpur, Punjab, now in Pakistan. His early education was at St. Thomas College, Murree. He joined Cambridge University in the Michaelmas Term in 1899. In September 1900 he migrated to Downing College. In 1902 he received the degree B.A. and L.L.B from Cambridge University. He was called to the Bar, Lincolns Inn on January 26, 1903. In 1902 he joined Exeter College, Oxford and received the degree of Bachelor in Civil law in 1904. He was a tennis blue in both Cambridge and Oxford.

On his return from England, he practiced at Lahore, and held the office of Government Advocate of Punjab. In 1907 in the Pindi Armoury case his father Lala Hans Raj Sawhny and Sardar Ajit Singh were arrested by the authorities and tried for conspiracy and insurgency against the British Crown. Bodh Raj Sawhny and Raizada Bhagat Ram Sondhi, Barrister from Jullundur defended the case and got them exonerated.

In 1910, Maharaja Pratap Singh, then ruler of Jammu and Kashmir State appointed Bodh Raj Sawhny as Chief Judge of the J&K Judicial Service at Jammu. Bodh Raj Sawhny was appointed Superintendent of the Camp during the Coronation Durbar of King George V and Queen Mary held at Delhi in December 1911. He was conferred the title of Rai Bahadur. Bodh Raj Sawhny was instrumental in framing the constitution of the High Court of Jammu and Kashmir and was elevated to the high court bench in 1928. He served in the high court from 1928 to 1936. During his tenure on the High Court bench he also acted as Chief Justice of Jammu and Kashmir.

### ***The Aims and objectives of the Trust are:***

2. To promote Conservation of the Environment, Upliftment of Women.

The Trust has instituted a scholarship for Indian students for the BCL course at The Exeter College at the Oxford University in the U.K.

# ABOUT THE DRAFTER



Rishabh Sancheti is an Advocate at the Supreme Court of India. He completed European Master in Law and Economics (EMLE) with a full scholarship from the European Union. He was chosen as an Erasmus Mundus Scholar. He has received LL.M. from University of Hamburg, Germany; Diploma di Master Universitario from University of Bologna, Italy; and another LL.M. from University of Vienna, Austria.

Prior to this, he graduated cum-laude from the National Law University, Jodhpur, with the S.R. Bhandari Memorial Gold Medal qualifying for B.B.A.-LL.B. (Hons.). His area of specialization was International Trade, Investment Laws and WTO Studies.

As an Advocate before the Supreme Court of India, he has appeared before several Constitution benches of the Supreme Court including Jindal Stainless (9 judges), Shrichand Harigopal (5 judges), Presidential Reference 1 of 2012 (5 judges), CBI v. Keshub Mahindra (Bhopal Gas Disaster matter) (5 judges), Jainarayan Chouksey (5 judges).

Cases in which he appeared have been reported from the Supreme Court of India, High Courts of Allahabad, Bombay, Chhattisgarh, Delhi, Madhya Pradesh, Rajasthan etc. He also regularly appears before Tribunals like the NCDRC, NCLT, NCLAT, NGT etc.

He has worked with Justice N. Santosh Hegde as a law clerk at the Supreme Court of India, and as paralegal with Amarchand Mangaldas Suresh N. Shroff, Mumbai and with P&A Law Offices, New Delhi. He has also worked at the office of Mr. Vivek K. Tankha, Additional Solicitor General of India and Member of Parliament, and at the office of Mr. Justice Vinit K. Mathur, the then Assistant Solicitor General at the Rajasthan High Court.
