# INSTRUCTIONS & PROCEDURE FOR REGISTRATION

## Eligibility

The Competition is open for all students who are pursuing a three-year or five-year Law Degree Course in Universities/Colleges/Law Departments in India, as recognized by the Bar Council of India. The Participants should send a picture of their University ID Card for verification.

## Date of Event

The 2<sup>nd</sup> National Bail Application and Argumentation Competition 2024-25 shall be held, from 06<sup>th</sup> July, 2024. It will be held offline.

## Procedure for Registration

Participation in the 2<sup>nd</sup> National Bail Application and Argumentation Competition is restricted to 30 teams only. The slots shall be reserved based on a 'first come' basis for the first 30 teams. The participating teams shall duly fill the Registration form provided at along with the Registration fee which shall be non-refundable. The registration fees shall be done through Online Transaction.

The teams should register through their respective Official College Email ID or any other recognized student association Email ID.



Kindly note that only two team per College/Institution/University shall be permitted to take part in the Competition. Confirmation mail and Team Codes shall be sent after the registration forms are successfully submitted by the teams. The last date for final registration shall be 1<sup>st</sup> July, 2024.
